The ultimate amount of shares to be received under the grant depended on the achievement of performance goals during a three-year performance period from January 1, 2015 through December 31, 2017. On February 22, 2018, Martin Marietta's Management Development and Compensation Committee certified the attainment of the applicable performance goals and approved the settlement of the PSU grant. The shares underlying the PSUs vested on December 31, 2017.
